Michael has been managing the Fund with Leigh since its inception in October 2008 while Leo and Tim joined the investment team in 2015 and 2017 respectively.

Going forward, Fairview will be majority owned by the three members of the investment team, Michael Glenane, Leo Barry and Tim Hall, with the NAB Group continuing to hold a minority interest. This strengthens the alignment of interests of the investment team and their aim to maximise returns for investors.

## Are there any changes to the way the Fund will be managed?

There will be no change to the way the Fund will be managed, and no change to the investment approach of the Fund. Fairview Equity Partners remains focussed on managing a core portfolio of Australian small cap equities for their investors.
