Portfolio changes

Effective date: 3 December 2024

We continually review the model portfolios to ensure they remain appropriately structured to meet their objectives and are well-positioned for the future market environment. These updates provide investment rationale for adding a new holding, removing an entire holding, or making a significant change to a Model Portfolio. Details of Portfolio re-weightings or re-balances occur normally in the course of managing the Portfolio and are included in our portfolio updates.

What changes have we made?

AGL Energy Ltd (AGL)	High Growth 98: +0.55% Growth 85: +0.50% Balanced 70: +0.45% Moderate 50: +0.40% Conservative 30: +0.35%	We have initiated a new position in AGL Energy Ltd (AGL). Our analyst sees improving direction for AGL, as forward electricity curves have started to move up quite noticeably in recent weeks, which is positive for financial year 2026 price caps and earnings during financial year 2026/2027 vs market expectations.
Reduction	Portfolio change	Rationale
BlueScope Steel Ltd (BSL)	High Growth 98: -0.55% Growth 85: -0.50% Balanced 70: -0.45% Moderate 50: -0.40% Conservative 30: -0.35%	We have exited our position in BlueScope Steel (BSL). BSL has contributed positively since we added it to the strategy in 2023. The stock has participated in the recent Trump election win bounce, but our own measures of 'Quality and Analyst's fair value', have deteriorated leaving the position less compelling.
