Worley Ltd	Aggressive: +0.40% Assertive: +0.40% Moderate: +0.40%	We re-established a position in engineering company Worley. Worley is leveraged to the improving capex cycle of oil and gas, growth in renewable energy transition, chemicals and mining and metals sectors, and is highly correlated to the oil price and commodity prices in general. Worley has over 30% of its pipeline in renewable energy projects, with clients involved in the transition from fossil fuels to renewable energy. Worley is investing significantly in research and development looking into how technology can meaningfully reduce emissions.
Removal	Portfolio change	Rationale
Harvey Norman Holdings Ltd	Aggressive: -0.40% Assertive: -0.40% Moderate: -0.40%	We exited the position in furniture and appliances retailer Harvey Norman. While retail goods sales are around currently 20% above pre-COVID levels, the consumer outlook is quickly shifting from one of extreme optimism, due to high levels of consumer stimulus, to pessimism caused by significant cost of living increases with significant global inflation.
